FUNDING YOUR VENTURE: A USERS GUIDE TO RISK CAPITAL

Rus Howard and Chad McDaniel will share their risk capital experiences at the May High Growth Business Club.

Rus is the founder of Phyton Inc., a biotech company that manufactures Taxol, a multibillion-dollar, blockbuster anticancer drug distributed by Bristol Myers Squibb. He is in the process of starting the Angel Venture Fund, an "angel" fund that functions like venture capital, but employs money from financially sound individuals rather than institutions.

Chad is an attorney at Clark, Partington, Hart, et al. whose practice includes the representation of entrepreneurs and private equity investors. Prior to recently joining the firm, Chad maintained an international practice with a large law firm in Boston, Massachusetts that focused on private equity fund formation, venture capital financing and representation of growth-oriented companies. Chad is also assisting Rus in organizing the Angel Venture Fund.
