BUSINESS INCUBATION

In 1991, Tim Handley founded Advantage Credit International which would later become the flagship company of the Aداugeo Group.

Handley's Advantage Credit was inducted into the Inc.500 "Hall of Fame" in 2003, an honor afforded to only 69 companies in the Inc.500's 22-year history. This accomplishment is especially notable considering Inc.500 alumni such as the once privately held Dell Computers and Microsoft never achieved the honor. Handley also received the Sam Walton Business Leader of the Year award in December 1999 for his business success.

In 2000, Handley launched the holding company that would later be named the Aداugeo Group. The name Aداugeo was chosen for the holding company as in Latin, it means "to make greater than." The desire and vision of The Aداugeo Group is to make businesses greater – greater than their competitors, greater than the industry standard and greater than their businesses have been in the past.

The Aداugeo Group quickly expanded in 2005, adding several information technology-driven companies along side its flagship company, Advantage Credit. The Aداugeo Group now operates and holds six companies.

The Aداugeo Group is a member of the National Business Incubation Association.
